



NOISE 5-3-3-B-22-A

Washington City Code states that it is unlawful to disturb the quiet, comfort of any person by making unreasonable loud noises. The following are examples of potential violations when prolonged: horns, stereos, yelling or shouting, motor vehicles, musical instruments, loud-speakers, construction work or equipment used in construction. Temporary permits can be applied for and granted.



ON STREET PARKING 5-2-3-I & 9-16-4

Washington City code states Vehicles such as boats, travel trailer, campers, etc. are to be parked off of the street. No long-term parking is allowed. Vehicles are not permitted to park on the city road for longer than 48 consecutive hours.

CODE ENFORCEMENT PROCESS

1. Resident or staff reports possible violation
2. Property is scheduled for inspection. Health & safety issues are addressed immediately
3. If violation exists, a notice will be left on the door, a letter sent or contact made with resident giving a period of time to correct the violation.
4. Property is re-inspected at the expiration of the time period.
5. If the violation has not been corrected a citation may be issued. Failure to correct a violation is a misdemeanor and subject to fines.
6. When a violation is resolved the case is closed.

CODE ENFORCEMENT MISSION

The Code Enforcement Office was created to enforce city, state, and federal laws that affect the standard of living in Washington City. These laws are generally either unknown or misunderstood. The Code Compliance Office is dedicated to educating the public on its rights as citizens and as its role as neighbors.

ILLEGAL POSTING 9-18-18-A

Washington City code states that no person shall post any sign to any public or private lands without obtaining a permit. No sign shall be attached to a utility pole, fence or tree. Any sign found posted upon any public property may be removed by any city official. The person responsible for any such posting can be liable for any cost incurred.



ILLEGAL DUMPING/LITTERING 5-3-3-B-30

Washington City Code states that Illegal Dumping/Littering is depositing, throwing or placing any trash, refuse, yard waste, construction materials or other unwanted materials on public or private property, for the purpose of temporarily storing/staging or permanently disposing of said items.



IMPROPER STORAGE 5-3-3-B-22-A

Washington City code states that improper storage is keeping, storing or accumulating old, unused machinery, junked vehicles, parts or personal property of any kind which is no longer safely usable.

Including Parking or storage of inoperative, unregistered, abandoned, wrecked or dismantled vehicles, boats and trailers. On the 1st Monday of each month Washington City will pick up items placed out on the curb at no charge. You must schedule the pickup with Public Works 435-656-6317



GARBAGE CONTAINERS 5-3-3-B-20

Washington City Code states that trash cans should not remain on the street other than on collection day and then not for more than 24 hours.



COMMERCIAL VEHICLES TO 9-16-11-A&B

Washington City Code states that semi trucks or trailers in the process of receiving or delivery may not be parked for more than 2 hours. Parking a truck or trailer that has more than 8 wheels touching the ground in a residential area is prohibited.



WEEDS 5-3-3-B-10 & 5-4-1

Washington City Code states that nuisances weeds are Noxious weeds located on vacant lots or other property, along public sidewalks or the outer edge of any public street, or weeds in any other location which constitute a fire and/or health hazard.

Undeveloped lots which have weeds or other growth that constitute a fire hazard shall be abated by disking, plowing or mowing the weeds within 4" of the ground.
