Construction, retail trade and healthcare/social services added the highest number of new positions. Washington County is now in the "zone" of not-too-fast-not-too-slow job growth.


BUSINESS COSTS

Dixie Technical College



Key Industry Employment Index



Key Industry Wages


Key industries were identified by their high location quotients, an indication of the concentration of the industry.
